## **Cross-cultural / National worker prayer adoption.**

### **Roles of Project Ablaze, Worker and Intercessor(s) <sup>1</sup>.**

#### **A. Prayer Coordinator's commitment (Project Ablaze):**

1. To request monthly prayer points and praise report from the **Worker<sup>2</sup>**, and send the received updates to the **Intercessor(s)** who adopted the worker.
2. If the **Worker** is comfortable to be in direct communication with the **Intercessor(s)**, Ablaze will make an introduction via zoom and connect both parties.
3. If the **Worker** is in a RAN/ CAN<sup>3</sup>, with security concerns, **Ablaze** will be the contact person who will receive the monthly updates and pass on to the **Intercessor(s)**.

#### **B. Worker's commitment:**

1. Provide monthly prayer points and praise report from the field so that the **Intercessor(s)** can pray specifically for you.
2. Update either **Ablaze** or the **Intercessor(s)** if prayers are answered.

#### **C. Intercessor(s)' commitment:**

1. Commit to pray on a regular schedule either daily, weekly or monthly.
2. Every month, write a handwritten prayer and an encouragement note for the **Worker**. Take a photo of both of it, and send it back to either the **Worker** or **Prayer Coordinator**.
3. The written prayer and encouragement notes are to be kept by the **Intercessor(s)**.
4. If a church/ group adopts the **Worker**, each committed intercessor in the group will write both the prayer and encouragement note individually.
5. **\*\*OPTIONAL:** Once a year, prepare a "care package" to be sent over to the worker on the field.

<sup>1</sup> Intercessor is defined as either a church/ group/ individual who commits to pray on a regular schedule and write to the worker.

<sup>2</sup> Worker is defined as either a foreign missionary or national from the nation.

<sup>3</sup> RAN: Restricted Access Nation / CAN: Creative Access Nation. (Sensitive/ high risk areas of ministry).

#### D. Other notes:

1. Communications with the **Worker** will be via a secure app like: Signal, Telegram, Threema, WhatsApp or an app of the worker's choice.
2. Messenger is strictly not to be used for ministry related communication with workers in high-risk locations.
3. We highly recommend that the **Intercessor(s)** use "[Microsoft Lens](#)" for taking photo of the prayer and encouragement note.
4. Security briefing will be given for writing the "Prayer and Encouragement notes". Full names, locations and ministries are not to be mentioned in the writing.
5. When our Ablaze team or an exposure team visits the **Worker** in their respective location, we will bring the "Prayer and Encouragement notes" written for them.
6. If situation allows, and the **Worker** is comfortable with direct communication, we highly encourage that the **Intercessor(s)** voice/ video call the worker to encourage and pray for the **Worker**.
7. We also highly recommend that the **Intercessor(s)** try to visit the **Worker**, if situation permits, to understand better who and what they are praying for. **Ablaze** will facilitate and organize the trip, so that the visit will be beneficial to both the **Worker** and **Intercessor**, and not burden the **Worker** on the field.
